


Why Switch to Parametric Custom Core®?

Customize


Want to tilt your portfolio toward, say, value stocks? Custom Core can do that. Have strong feelings about environmental or social issues? You can screen out specific industries or individual companies.

Potentially increase your after-tax returns

Through gain deferral, yield consideration, and other tax-management techniques, Custom Core seeks an additional 1%–2% in annualized after-tax returns.

How transitions work

Whether you fund your account with cash, existing securities, or a combination of the two, Parametric makes transitions easy, allowing you to choose how closely you want to track your selected benchmark balanced against any taxes you'll owe.



Regardless of the approach you decide to take, over time Parametric can work to reduce tracking error to bring your holdings closer to your selected benchmark, typically without causing you to incur a significant tax penalty. Parametric can also complete the transition in stages, further driving down any potential tax liability.

Why Parametric?

Parametric pioneered tax-managed investing close to 30 years ago and was among the first to recognize that, for many high-net-worth investors, taxes can represent a larger drag on returns than fees or trading costs.
