

## Treasury Yields Spike After Jobs Report

Yields on the long and short end moved sharply higher after data on Friday painted a picture of a robust job market.

The benchmark 10-year yield pulled up to 4.233% from 4.156%, while the 2-year jumped to 4.669%, up 78 basis points from the last close.
